Plateau \$26.00 with a limit of 3 gallons, and to leave the gallons in the program at 40
Facet and Method to be sold at our cost

Barth moved and Johnson seconded to advertise for bids for chemicals with bids to be opened at the March meeting as follows:

- 150 gallons Tordon 22K in one gallon containers
- 130 gallons Curtail in two and one-half gallon containers
- 50 gallons Plateau in one gallon containers
- 20 gallons Facet L in one gallon containers
- 20 gallons Method in quart containers
