

MORTON COUNTY COMMISSION REGULAR MEETING
December 28, 2021

The Morton County Commission Regular Meeting was called to order on December 28, 2021 at 5:30 PM by Chairman Leingang at the Morton County Courthouse, 210 Second Avenue NW, Mandan, North Dakota. Others present were Commissioners Zachmeier, Buckley, Boehm and Morrell, Auditor Rhone and States Attorney Kopyy.

Buckley moved and Morrell seconded to approve the agenda. All voting aye, motion carried.

Boehm moved and Buckley seconded to approve the minutes of the December 9, 2021 regular meeting. All voting aye, motion carried.

Buckley moved and Boehm seconded to approve the bills and payroll. All voting aye, motion carried.

Boehm moved and Buckley seconded to approve abatements #6001-6014 & 6021-6022. All voting aye, motion carried.

Buckley moved and Morrell seconded to approve abatement #6015. All voting aye, motion carried.

Boehm moved and Morrell seconded to approve abatements #6016-6017. All voting aye, motion carried.

Morrell moved and Zachmeier seconded to authorize Auditor Rhone to contract a consultant to evaluate the structural integrity of the memorial wall. All voting aye, motion carried.

Morrell moved and Zachmeier seconded to approve the final plat of the short-form subdivision known as Tschida Subdivision, a zoning map amendment from Agricultural (A) District to Residential (R) District, as the subdivision conforms to the regulations established in Article 7 of the Morton County Land Use Code and is not in violation of Policy 1.1.2 of the Morton County Comprehensive Plan. Boehm moved and Buckley seconded to approve the election precincts as presented by Auditor Rhone. All voting aye, motion carried.

Buckley moved and Zachmeier seconded to approve the Courtroom Facilities Grant application as presented. All voting aye, motion carried.

Morrell moved and Boehm seconded to approve 2022 liquor and beer licenses for The Watering Hole, Huff Hills, Rusty's, The Wet Spot and Venue Twenty 5. All voting aye, motion carried.

Boehm moved and Morrell seconded to adjourn the meeting at 6:26 PM. All voting aye, motion carried.
