## MORTON COUNTY PARK BOARD MEETING April 23, 2019

  We had three other bidders they were TJ Enterprise, Schlosser Excavating, and Interstate Excavating.
- 2. I had a request to allow pit Bar-Be-Ques at Graner Park. To the best of memory we did allow these back in the early nineties. They were a terrible mess. Every time there was a new pit dug it just got bigger and bigger. The mess came from the coals that were dug up each time. We even went as far as building a pit out of cement blocks and lining it with steel. It worked one time and then the block just fell apart. I honestly can't remember why they were not allowed after that. I'm sure this would have to be permitted by the Corp and if they would allow it there would be some rules that would have to be followed. In my opinion this is something we don't want to allow. However if this is something the Board wants to allow and the Corps gives permission we will make it work.

## 3. Park Updates:

- a. The shop is at a standstill, we are waiting for Schlosser Excavating to come in and get the water pit installed. Than Clay's Plumbing can install the septic system.
- b. The crew has been getting the Park System up and running. It has be a challenge with the weather conditions.
- c. The camping season is off to a slow start with the cool wet weather. The revenue will be given at the meeting.
